

**SIoux FALLS METROPOLITAN PLANNING ORGANIZATION
RESOLUTION #2017-01**

A MINOR UPDATE TO THE GO SIOUX FALLS MPO 2040 LONG-RANGE TRANSPORTATION PLAN FOR THE ADDITION AND REVISION OF VARIOUS PROJECTS

WHEREAS, in Table 8-10 on page 120 of the Go Sioux Falls MPO 2040 Long-Range Transportation Plan (LRTP), I-29, I-229 and I-90 Mainline and Interchange Improvements are identified as prioritized and fiscally constrained projects in the 2021-2025 timeframe for the Sioux Falls MPO planning area;

WHEREAS, additional planning study work has been conducted and specific projects have been developed and prioritized for the I-29, I-229 and I-90 Mainline and Interchange Improvements;

WHEREAS, in Table 8-3 on page 112 of the Go Sioux Falls MPO 2040 Long-Range Transportation Plan (LRTP), Roadway Capital Revenues are identified for the Sioux Falls MPO planning area;

WHEREAS, additional funding from the State of South Dakota's fuel tax increase has been committed for the I-29, I-229 and I-90 Mainline and Interchange Improvements;

WHEREAS, the City of Sioux Falls will fund, by reprioritization and reduction of projects in the LRTP, and will coordinate associated urban street improvements with the I-29, I-229, and I-90 Mainline and Interchange Improvements. The improvements will be funded with local funds and Surface Transportation Block Grant Program Funds (STBG).

WHEREAS, the I-29, I-229 and I-90 Mainline and Interchange Improvements are committed, fiscally constrained projects that may be programmed in the Sioux Falls Metropolitan Planning Organization's Transportation Improvement Program (TIP); and

WHEREAS, projects programmed in the TIP must conform to the LRTP.

NOW, THEREFORE, BE IT RESOLVED

1. That the three I-229 Interstate Improvements (Determined by MIS) projects identified in the 2021-2025 timeframe in Table 8-10 on page 120 of the LRTP, will be deleted as a SDDOT Financially Constrained Capital Roadway Projects.
2. That the W 60th St. North: I-29, E.0.5 mi to N Westport Ave. Project, with a project type of Capacity – 4 lanes, will be revised as a City of Sioux Falls Financially Constrained Capital Roadway Projects in the 2016-2020 timeframe in Table 8-10 on page 118 of the LRTP to reduce the cost to \$1,000,000.
3. That the W 60th St. North: Kiwanis to N 4th Ave. Project, with a project type of Capacity – 4 lanes, will be revised as a City of Sioux Falls Financially Constrained Capital Roadway

Projects in Table 8-10 on page 118 of the LRTP to move the project to the 2036-2040 timeframe and adjust the cost for inflation to \$46,902,000.

4. That the 10th Street: ¼ mile east Cleveland to Foss Project, with a project type of Capacity – 6 lanes, will be revised as a City of Sioux Falls Financially Constrained Capital Roadway Projects in the 2021-2025 timeframe in Table 8-10 on page 118 of the LRTP to reduce the cost to \$6,641,000.
5. That the 10th Street: Lowell to ¼ mile east Cleveland (including interchange) Project, with a project type of Capacity – 6 lanes, will be revised as a City of Sioux Falls Financially Constrained Capital Roadway Projects in the 2021-2025 timeframe in Table 8-10 on page 119 of the LRTP to reduce the cost to \$2,460,000.
6. That the 57th Street: Six-Mile Rd. to 481st Street Project, with a project type of Capacity – 4 lanes, will be revised as a City of Sioux Falls Financially Constrained Capital Roadway Projects in Table 8-10 on page 119 of the LRTP to move the project to the Beyond 2040 timeframe and adjust the cost for inflation to \$73,382,000.
7. That the I-29 Exit 77 (41st St): I-29/41st St. Project, with a project type of Interchange Improvements, will be revised as a SDDOT Financially Constrained Capital Roadway Projects in the 2021-2025 timeframe in Table 8-10 on page 120 of the LRTP to increase the cost to \$22,000,000; and the boundary in the Project Name of the 41st Street: Marion to I-29 Project, with a project type of Capacity – 6 lanes, will be revised as a City of Sioux Falls Financially Constrained Capital Roadway Projects in the 2016-2020 timeframe in Table 8-10 on page 118 of the LRTP to 41st Street: Marion Road to Shirley Avenue.
8. That the I-229 60th St. North Over I-229 South of I-90 Project, with a project type of Replace Structure and cost of \$4,330,000, will be added as a SDDOT Financially Constrained Capital Roadway Projects in the 2021-2025 timeframe in Table 8-10 on page 120 of the LRTP.
9. That the I-229 Corridor Project, with a project type of ITS Improvements and Median Lighting and cost of \$7,898,000, will be added as a SDDOT Financially Constrained Capital Roadway Projects in the 2021-2025 timeframe in Table 8-10 on page 120 of the LRTP.
10. That the I-90 Exit 406 (SD 11 Brandon): I-90/SD11 in Brandon Project, with a project type of Interchange Improvements, will be revised as a SDDOT Financially Constrained Capital Roadway Projects in the 2021-2025 timeframe in Table 8-10 on page 120 of the LRTP to increase the cost to \$21,200,000.
11. That the I-229 Exit 9 (Benson Road) Project, with a project type of Interchange Improvements and cost of \$30,191,000, will be added as a SDDOT Financially Constrained Capital Roadway Projects in the 2021-2025 timeframe in Table 8-10 on page 120 of the LRTP. Included in the project cost is the City of Sioux Falls' estimated cost of \$1,000,000 for associated project improvements which will be funded by City STBG and/or Local Funds.


12. That the I-229 Exit 3 (Minnesota Ave) Project, with a project type of Interchange Improvements and cost of \$34,695,000, will be added as a SDDOT Financially Constrained Capital Roadway Projects in the 2021-2025 timeframe in Table 8-10 on page 120 of the LRTP. Included in the project cost is the City of Sioux Falls' estimated cost of \$10,000,000 for associated project improvements which will be funded by City STBG and/or Local Funds.
13. That the I-229 Exit 4 (Cliff Ave) Project, with a project type of Interchange Improvements and cost of \$24,175,000, will be added as a SDDOT Financially Constrained Capital Roadway Projects in the 2021-2025 timeframe in Table 8-10 on page 120 of the LRTP. Included in the project cost is the City of Sioux Falls' estimated cost of \$2,219,000 for associated projects improvement which will be funded by City STBG and/or Local Funds.
14. That the SDDOT Roadway Capital Revenue will be increased to \$155,818,000 in the 2021-2025 timeframe in Table 8-3 on page 112 of the LRTP.
15. That no change is necessary to the City of Sioux Falls' Roadway Capital Revenue shown in Table 8-3 on page 112 of the LRTP due to the project reprioritizations and reductions.
