JUSTIFICATION: The Transportation Commission approved a future jurisdictional transfer of South Veterans Parkway (Hwy 100) from I29 to 57th Street. The existing agreement will be amended for the State to provide funding to the City to complete final design, ROW acquisition, certifications, and contract administration for construction of the remaining south segment of the corridor. The construction will be completed via four (4) projects. The State will fund all work and provide oversight for each project. The funding will be based on actual eligible expenses incurred for both design and construction.
